The current fee for this category is EUR 58 per year.

Association Affiliates will have free membership registration with the Management of Library Associations Section and — where applicable — with the appropriate Regional Activities Section (Africa, Asia & Oceania or Latin America & the Caribbean). Association Affiliates have no voting rights. Association Affiliates will have all other member services and entitlements that are applicable to Affiliation membership. Association Affiliation is possible for two consecutive years, after which the membership will be upgraded to the appropriate Band, with the corresponding costs and benefits.

## October 2011: IFLA's Open Access Taskforce established

Following the endorsement of IFLA's statement on open access (<http://www.ifla.org/files/hq/news/documents/ifla-statement-on-open-access.pdf>) by the Governing Board, April 18th 2011 and the subsequent approval from the Governing Board during the WLIC in Puerto Rico August 2011 of a number of key initiatives, IFLA's Open Access Taskforce has been established.

The taskforce will work on the following issues:  
Advocate for the adoption and promotion of open access policies as set out in IFLA's Statement on Open Access within the framework of the United Nations institutions (UN, UNESCO, WHO, FAO),  
Build Capacity within the IFLA Membership to advocate for the adoption of open access policies at the national level, through the development of case studies and best practices for open access promotion

## **IFLA- Code of Ethics for Librarians and other Information Workers**

Librarians all over the world are well aware of their profession's ethical implications. In more than 60 countries library associations have developed and approved a national code of ethics for librarians. FAIFE has collected nearly 40 of them and makes them available in the list "Professional Codes of Ethics for Librarians".

FAIFE took the decision to task a working group with drafting an International or IFLA-Code of Ethics for Librarians. The working group consists of 5 members from 5 countries who are members or former members of the FAIFE committee (Loida Garcia-Febo, Anne Hustad, Hermann Rosch, Paul Sturges and Amelie Vallotton). In addition, outside experts have been included in the discussions. Now the group presented a first draft:

## **Section's Annual Report 2010-2011**

### **Scope Statement**

The Classification and Indexing Section focuses on methods of providing subject access in catalogues, bibliographies, and indexes to documents of all kinds, including electronic documents. It serves as a forum for producers and users of classification and subject indexing tools. It works to facilitate international exchange of information about methods of providing subject access; to promote standardization and uniform application of classification and subject indexing tools; to initiate and promote advice on research in the subject approach to information; and to disseminate research results through open meetings and publications.

### **Highlights**

In San Juan our Section presented an excellent open programme entitled "Bridging domains, communities and systems". The session was a great success and the papers all quite interesting and useful. The next programme, in Helsinki, will also be a two hour session organized by our Section. We will also be presenting a post-conference in collaboration with the National Library of Estonia in Tallinn. Section members have also actively participated in the Working Group on Guidelines for Subject Access by National Bibliographies (WG NBA). The section continues to cooperate with the Cataloguing and Bibliography sections, UNIMARC, in the Semantic Web Special Interest Group and other IFLA activities related to bibliographic control.

### **Membership**

The section has 74 institutional, 12 association and 9 individual members for a total of 95 members from 37 countries.

### **Standing Committee and officers**

This year was an election year. We have said goodbye and thank you to outgoing members Patrice Landry, Anne-Céline Lambotte, Dorothy McGarry, David Miller, Bernadette Patte, Thordis T. Thorarinsdottir and Barbara Tillett and welcomed new members John DeSantis, USA, Mauro Guerrini, Italy, John Hostage, USA and Sun Mi Kim, Korea. Marie Balikova, Czech Republic, is a returning member and Gordon Dunsire is starting his second term. The Standing Committee has 17 members from 12 countries. There are also 6 corresponding members from 6 countries. The following nations are represented: Brazil, Canada, Cuba,

Estonia, France, Germany, India, Iran, Italy, Portugal, Russian Federation, Slovenia, Sweden, United Kingdom, and the United States. Jo-Anne Bélair and Magdalena Svanberg have been reelected Chair/Treasurer and Secretary for 2011-2013. Sandy Roe has graciously accepted to assume the tasks of Information Coordinator and Yvonne Jahns those of Newsletter editor.

### **San Juan conference, August 2011**

The open programme presented by the Section, entitled "Bridging domains, communities and systems", was presented at the 2011 San Juan Conference. The programme attracted about 125 people. The programme consisted of four very interesting papers by Emmanuelle Bermès (Bibliothèque nationale de France, Paris, France), Dierk Eichel (University of Applied Sciences, Potsdam, Germany), Oshiba Tadahiko (National Diet Library, Tokyo, Japan) and Barbara Tillett, Libby Dechman, and Loche McLean (Library of Congress, Washington, D.C., USA). Other members of our section were participants in other sessions. Maja Žumer (University of Ljubljana, Ljubljana, Slovenia) in the papers entitled "Breaking barriers between old practices and new demands: the price of hesitation" (session 80) and "UNIMARC and FRBR – can we have both?" (session 187) and Gordon Dunsire in the paper entitled "UNIMARC and linked data" (session 187).

The Section had its Standing Committee meeting in two sessions during the San Juan conference. The first session was attended by 21 members (both incoming and outgoing) and the second meeting by 15 members. Observers were in good number at both meetings. Continuing working groups reported on their activities. Plans for the 2012 open session and satellite meeting were discussed. Working groups had their meetings separately during the conference. The officers participated in the Division's officers' meeting, held in two sessions, during the conference.

### **Projects and working groups**

The WG on Guidelines for Subject Access by NBAs has Yvonne Jahns as the chair. The final draft was posted on the IFLA website in mid-May for World Wide Review. The World Wide Review ended in July and resulted in eleven comments. Two meetings were held during the IFLA conference to discuss the feedback. A final version was approved by the Classification & Indexing and Bibliography SCs until December.

## **IFLA Namespaces Task Group**

The first meeting of the IFLA Namespaces Task Group took place on 15 August 2011 during the IFLA conference in Puerto Rico. A report of the meeting is available as item 16.1 in the [minutes of the Classification and Indexing Section SC meetings](#) item.

There have been several related developments since that meeting.

A Report on recent activity of the IFLA Namespaces Task Group and the DCMI/RDA Task Group was given as a presentation to the IFLA Semantic Web Special Interest Group on 17 August 2011.

Several members of IFLA groups attended the Vocabulary Management and Alignment special session at the Dublin Core 2011 conference in The Hague, The Netherlands, on 21 September 2011. Feedback from participants has resulted in the formation of a **DCMI Vocabulary Management Community** as “a forum and collaboration space for those interested in defining and documenting best practices for vocabularies, providing guidance for new practitioners, and promoting responsible change management. In addition, the Community will address design and quality issues in vocabularies and mappings in a modern Semantic Web environment.” The Community has an open membership; further information is available at

<http://dublincore.org/groups/vocabulary- management/>.

Bibliographic metadata and mappings were widely discussed at the full conference; the papers are available at <http://dcevents.dublincore.org/index.php/IntCo nf/dc-2011/schedConf/presentations>.

The DCMI/RDA Task Group has been succeeded by an expanded **DCMI Bibliographic Metadata Task Group**. Representatives of IFLA groups involved with namespaces, linked data, and the Semantic Web will be invited to join the Group to collaborate on activities of common interest, including application profiles and element set and vocabulary mappings. The final report of the W3C Library Linked Data Incubator Group (<http://www.w3.org/2005/Incubator/lld/XGR->

[lId-20111025/](#)) was published on 25 October 2011. The key recommendations are that library leaders identify sets of data as possible candidates for early exposure as Linked Data and foster a discussion about Open Data and rights; that library standards bodies increase library participation in Semantic Web standardization, develop library data standards that are compatible with Linked Data, and disseminate best-practice design patterns tailored to library Linked Data; that data and systems designers design enhanced user services based on Linked Data capabilities, create URIs for the items in library datasets, develop policies for managing RDF vocabularies and their URIs, and express library data by re-using or mapping to existing Linked Data vocabularies; and that librarians and archivists preserve Linked Data element sets and value vocabularies and apply library experience in curation and long-term preservation to Linked Data datasets. All of these involve the policies and activities identified by the IFLA Namespaces Task Group in its first report to the Professional Committee. Action on that report is now included in the remit of the new IFLA Committee on Standards.

The final report is accompanied by a [report on Datasets, Value Vocabularies, and Metadata Element Sets](#), which includes the IFLA namespaces, and a [report on Use Cases](#).

**Representatives of the ISBD Review Group and the ISSN Network met with the Joint Steering Committee for Development of RDA in Glasgow, Scotland, in November 2011**, to discuss alignment between the new consolidated edition of ISBD, the ISSN record schema, and RDA: Resource Description and Access. Alignment and mapping of the related namespaces was included on the agenda. In particular, the plans for developing a namespace for the RDA/ONIX Framework with mappings from the ISBD and RDA content and carrier categories should be of interest to all IFLA bibliographic standards and namespaces. Mappings between the ISBD and RDA element sets were also discussed. Further information is available in the ISBD Review Group report in the [number 36 issue of SCATNews](#).

## **Guidelines for Subject Access by National Bibliographic Agencies approved**

The Section's WG existed from 2004 to 2011 to

- Look at national indexing policies of national libraries and national bibliographic agencies to consider what kind of access should be given to the different groups of users (stakeholders) of national bibliographies,
- Provide recommendations on the selection of documents to be given subject access and propose various levels of indexing and classification, and
- Establish guidelines (minimal requirements) in addition to the Guidelines for National Bibliographies in The Electronic Age ensuring that appropriate subject access is given by national bibliographic agencies to meet user needs.

These goals have now been achieved!

The project will be completed by a publication of the Guidelines in 2012.

After a World-wide review between May and July 2011 comments were received from the National Libraries of New Zealand, Canada, the Czech Republic, Israel, Latvia, Austria, Italy (Florence), Denmark, Australia and the U.S. Agricultural Library and one personal feedback from Pat Riva/Québec. Most of the comments were positive feedback on the national examples, but some others had very useful ideas and interesting questions, e.g. regarding terminology. The Working Group was happy to receive all these comments and finalized the Guidelines after having two final meetings at the IFLA WLIC San Juan, Puerto Rico.

The final version could be submitted for Approval by the C&I section and Bibliography section at the beginning of November 2011.

MuLDiCat started in the Cataloguing section, but now all bibliographic sections are involved. It is intended to be used when translating IFLA documents and other cataloguing codes.





### **Dewey Decimal Classification News**

#### **DDC 23**

Edition 23 of the Dewey Decimal Classification and Relative Index (DDC 23) was published in April 2011. #### **Abridged Edition 15 and 200 Religion Class**

Abridged Edition 15 and 200 Religion Class will be published in early 2012. Both publications are based on an updated version of the DDC 23 database.

#### **WebDewey 2.0**

[WebDewey 2.0](#) features an easy-to-navigate user interface with local control over the display of record elements, a generic user interface script to support access to Dewey data in different languages, and access to different mapped terminology sets. Recent enhancements introduced in November 2011 include display of the history information associated with each class, the inclusion of new icons to identify built numbers (a puzzle piece icon) and Manual notes (a book icon), a new opening screen, extended default search preferences, and direct links to Dewey updates from each web page. Future releases of WebDewey 2.0 will include number-building assistance and support for WebDewey as a source of user-generated content.

#### **Dewey.info**

[Dewey.info](#), an experimental space for linked DDC data, currently contains the top 3 levels of the DDC in 11 languages, plus assignable numbers accompanied by captions from the English, Italian, and Vietnamese DDC Abridged Edition 14 data sets.

#### **Decimal Classification Editorial Policy Committee (EPC)**

The Decimal Classification Editorial Policy Committee (EPC) held Meeting 134 at OCLC headquarters in Dublin, Ohio, 8–10 June 2011. The agenda included review of the proposed content for Abridged Edition 15 and 200 Religion Class, plus consideration of several papers on strategic directions for the DDC. The committee has held several follow-up electronic meetings to complete review of the content for Abridged Edition 15 and 200 Religion Class, plus updates to DDC 23.

#### **DDC 23 and beyond: Linking the local, regional, and global with Dewey**

*"DDC 23 and beyond: Linking the local, regional, and global with Dewey"*, a special interactive session on the DDC, will be held in conjunction with the OCLC EMEA Regional Council Third Annual Meeting on 28 February 2012 in Birmingham, United Kingdom. Three presentations covering the current Dewey ecosystem, the role of viewpoint and the worldwide user community in the evolution of the DDC, and Dewey linked data initiatives will provide a springboard for a lively discussion among participants. Facilitators include Caroline Kent (Monographic Processing Manager, The British Library [and Chair, EPC]), Joan S. Mitchell (Editor in Chief, DDC, OCLC), and Neil Wilson (Head of Metadata Services, The British Library).

#### **Dewey Staff News**

Giles Martin, assistant editor of the DDC since 1999, retired from OCLC in August 2011 and returned to Australia. During his tenure as assistant editor, Mr. Martin played a pivotal role in the development of several schedules, the elimination of unbalanced spans, and the conversion of DDC data from a proprietary format to one based on the MARC 21 formats for classification and authority data. Mr. Martin, the first member of the editorial staff from outside the United States, joined the editorial team in 1999 after a distinguished career that included the following professional posts: cataloguer, University of Sydney; librarian, systems section, University of New South Wales Library; and successive posts at the University of Newcastle Libraries as librarian, senior librarian (cataloguing), head cataloguer, deputy technical services librarian (monographs), and librarian in charge of quality control. Prior to his appointment as assistant editor, Mr. Martin was a member of the Decimal Classification Editorial Policy Committee 1993–1999, served on the Australian Bibliographic Network (ABN) Standards Committee, the ABN Subject Headings

Review Panel and the Australian Committee on Cataloguing.

Letitia (Tish) Reigle, a member of the Library of Congress U.S. General Division's Dewey Section (and its predecessor, the Decimal Classification Division) for the last 35 years, passed away 4 August 2011.

Eve Dickey, head of the Dewey Section at the Library of Congress, plans to retire 31 December 2011 after 42 years of U.S. Federal service. Eve has been closely associated with Dewey application for 40 years, and has led the Dewey Section for the last 7 years. The Dewey editorial team and the worldwide Dewey community have particularly benefited from Ms. Dickey's expertise in law, sociology, and education.

versions of the UDC Master Reference File (UDC MRF). Old editions in the following languages were already aligned in 2010-2011: Bulgarian, Croatian, Czech, Dutch, French, German, Portuguese, Spanish and Swedish and their translation is underway

- **Hosting online translation database** - designed for the preparation of new editions, the service supports exports/uploads and backups and databases are available for both complete UDC MRF translation and for the standard pocket edition. This service proves to be a popular choice for publishers who do not have the resources to develop their own tools and would like to prepare their editions in the shortest possible time.

In the following years UDCC plans to collaborate and build partnerships with national libraries and bibliographic centers to better support bibliographical services and information exchange in a multilingual context.

## UDC News

2011 was a very busy year for the UDC team and we end the year with several new developments that we hope will make a big difference to UDC users in the future. In September, we also held our third biennial International UDC Seminar followed by the second UDC Editorial Workshop.

### Improving support for publishers

Thanks to its previous owner FID - for most of the 20th century, UDC was the most widely translated classification in the world. By the 1980s there were translations of UDC in 39 languages

([http://www.udcc.org/files/UDCeditions\\_bibliography10March2011.pdf](http://www.udcc.org/files/UDCeditions_bibliography10March2011.pdf)). This situation has significantly changed since 1980s and since then many old editions have never been updated. This causes problems for users because of the fact that in the period from 1990-2010, 40% of the UDC was changed, over 10,000 classes were cancelled and 20,000 new classes added to the schedule. In many countries UDC publishers are very often national libraries or library associations. Therefore, the priority now is to help reduce the cost of publishing and printing new editions. The first step in addressing this was taken in 2009 by introducing more practical and more affordable publishing licenses and in 2011 the following two services were provided to institutions publishing the UDC:

- **Align of old editions** - UDC data services for publishers of the national editions by aligning texts of their old language editions with the latest

### Supporting UDC users

**Access to free abridged UDC schedules** - multilingual UDC Summary now has 46 languages online and we are hoping to add more in January. Of the languages available in December 2011, 26 have fully translated captions and 16 have the complete text of the schedules in almost 2,500 classes translated. In many countries in which there are few or no UDC editions available, the online UDC Summary or its free downloads are used for training and indexing. The level of use and support for this tool is overwhelming and the UDC team of volunteers working on the UDC Summary has very exciting plans for its expansion in 2012. UDC Summary can be accessed at <http://www.udcc.org/udcsummary/php/index.php>.

**UDC as linked data** or to be specific a SKOS dump of UDC Summary in 26 languages was published as linked data (on 18 November). Both static and dynamic exports are available and can be accessed from (<http://www.udcc.org/udcsummary/exports.htm>) This export currently contains only UDC data that can be expressed as SKOS data and an extension of this set is planned for January 2012. More tools and services will be built around the XML/RDF export this

**Managing historical UDC data** to support information exchange - in 2011 we have expanded the UDC data set with cancelled numbers and concordances between cancellations and new numbers to enable services and tools for

automatic redirection and management of UDC updates. We have started retrospectively adding into the UDC database numbers that were removed from the system during the past 30-40 years and will provide tracing between cancelled and replaced numbers, concepts and notational representations

**Helping user communities** - in 2011 we made some progress in improving support for Spanish/Portuguese speaking users. We pleased to inform everyone that we now have an editor dedicated to providing support and help handling queries in Spain and South America. The UDC list in Spanish and the UDC blog in Spanish are currently used as the main channels for this support

(<http://clasificaciondecimaluniversal.blogspot.com/>). Following the redesign of the UDCC website next year - more information and useful materials will be provided to user communities in different languages and in different regions of the world.

### **UDC content development in 2011**

In 2011 the content revision of UDC intensified in the area of common auxiliaries of place, class 5 and class 6. Following the publication of the Extensions and Corrections to the UDC 32(2010), the latest UDC MRF was released with over 69,000 classes. It contains 1,200 new classes, changes to 1,100 classes and cancellations of 600 classes. The South American countries were revised in the place table, and new and more detailed place subdivisions for Armenia, Georgia, Azerbaijan and Kazakhstan were published. Most importantly class 59 Vertebrates was completely revised and brought up to date. A revision of the entire systematic biology is planned for completion in 2014. Changes in class 6 mostly contain restructuring and reduction of concept repetition in special auxiliary tables.

Other work on the revision of philosophy, form tables, place table, language table, library and information science, music and art periods is underway.

One of the most important tasks for the new UDC editorial team is to asses how UDC content development affects users and library collection management. The UDC Editorial Workshop 2011 provided an opportunity to open such a discussion. The workshop took place on 21 September 2011 in The Hague, in conjunction with the UDC Seminar 2011 and was attended by UDC editors, members of the UDC Advisory board and invited guests. The workshop covered topics related to the direction, policy and priorities of the revision of UDC. Some issues illustrated by the revision reports were also noted to be of

concern to editors of the Dewey and Bliss classifications, who were present.

### **Report and outputs of the International UDC Seminar 2011**

The third biennial UDC International Seminar "Classification & Ontology: Formal Approaches and Access to Knowledge" took place on 19-20 September in the National Library of the Netherlands, The Hague, and was a successful and well attended conference.

Although the topic was rather specialised, 141 delegates from 30 countries across Europe, Asia, North America, South America and Australia attended. The keynote address by Patrick Hayes opened a two-day programme consisting of 21 talks and two poster presentations.

Proceedings of the conference were published by Ergon Verlag and were distributed in delegate packs. The book is now available for purchase from

A number of talks stressed the urgency for knowledge classification schemes to be published as linked data and the limitations of the existing web ontology standards in expressing semantics were also explained. Presentations about particular schemes illustrated that classifications may indeed require more thought with regards to modeling.

The next International UDC Seminar is planned for 24-25 October 2013. The call for paper will be distributed in summer 2012.

The mission of the Library Linked Data Incubator Group was to help increase the global interoperability of library data on the Web by focusing on the potential role of Linked Data technologies.

In its final report, the group characterized the current state of library data management, outlined the potential benefits of publishing library data as Linked Data, and formulated next-step recommendations for library standards bodies, data and systems designers, librarians and archivists, and library leaders.

The main report of the group is supplemented by two more detailed reports. "Use Cases" describes library applications which showcase the benefits of adopting Semantic Web standards and Linked Data principles to publish library assets such as bibliographic data, concept schemes, and authority files. "Datasets, Value Vocabularies, and Metadata Element Sets" provides a snapshot of key resources available for creating library Linked Data today.

## **European RDA Interest Group (EURIG)**

The European RDA Interest Group (EURIG) was formally launched in Copenhagen on 27th September 2011. The EURIG Cooperation Agreement was signed by: Dame Lynne Brindley, Chief Executive of the British Library; Dr. Elisabeth Niggemann, Director General of the Deutsche Nationalbibliothek; Mrs. Glòria Pérez-Salmerón, Director of the Biblioteca Nacional de España and Dr. Gunnar Sahlin, National Librarian of Sweden and Director of the Royal Library.

EURIG exists to promote the common professional interests of all users, and potential users, of RDA: Resource Description and Access, in Europe.

RDA: Resource Description and Access has been developed to supersede the widely adopted Anglo-American Cataloguing Rules (AACR2). One of the design objectives of RDA is to develop a cataloguing code which is compatible with internationally established principles, models, and standards.

EURIG developed from informal discussions between European national libraries concerned with the development, translation and implementation of RDA.

Alan Danskin, Chair of the Joint Steering Committee for Development of RDA, commented, "JSC is grateful for the many thoughtful responses contributed to the RDA development project by librarians from across Europe. I am sure

EURIG will provide a valuable collaborative space for European libraries as they grapple with translation and implementation and engage in RDA's continuing development. It is also fitting that the EURIG Cooperation agreement should be signed in Copenhagen, which hosted EURIG's kick-off meeting last year. "EURIG's future plans include an inaugural members' meeting which will take place in December, to be followed by a technical meeting in early 2012.

### Taiwan Airport opens high-tech e-library for transit passengers

Transfer passengers at Taiwan Taoyuan International Airport enjoy the new library facilities. An airport in Taiwan has turned a new chapter by opening what it calls the first e-library for transfer passengers at an airport.

Travellers making a connection at Taiwan Taoyuan International can now borrow an iPad or e-book reader and indulge in a popular pastime while they wait. Each e-device holds around 400 titles from different genres, available in English and Chinese. The new library – in the waiting room near gate C5 in Terminal 2 – is also stocked with regular books. Bookworm travellers may have a struggle to get their hands on one of the 30 e-book devices and iPads, which are being loaned out on a first come first served basis.

It is not the only library to have sprung up at an airport.

In September 2010, Terminal U reported on the opening of Amsterdam Schiphol's permanent library, which features 12,000 books showcasing Dutch history, culture, art and literature, in 29 languages.
