The KM Section implemented a series of activities during the WLIC 2017: a satellite preconference, an open session and the 4th Knowledge Café, an award plus two business meetings. The KM Section sponsored the newly created Digital Humanities / Digital Scholarship Special Interest Group (DH/DS SIG). All activities were successful and well attended.

The satellite preconference was organized at the [Library of the Wrocław University of Economics](#) on Friday 18 August 2017. The theme was “New directions in knowledge management.” Twelve countries were represented with the 40 participants. The keynote speaker, Dr. Joanna Paliszkiwicz, presented the future of knowledge management. The eight speakers presented topics on the theory and practice of knowledge management and technological innovations such as robots in libraries. All presentations are available at the conference [website](#) and the full papers are available at the [IFLA Library](#). The catering services were graciously offered by Springer Nature China.

The open session was organized on 24-8-2017 (Session 230). The topic was “How does knowledge management inform change agency?” It was attended by 237 delegates. Andreas Degkwitz, the keynote speaker, referred to the library as a virtual makerspace which is the future knowledge management. The six presentations showcased examples of knowledge management at work to prepare and facilitate change. An innovation of the session was the Q&A part engaging the audience with the social media. The open session was successfully co-chaired by Liz Turner (**f**) and Leda Bultrini. Theirs and the rest of the team’s wonderful work was reflected on the big number of attendees of the Session (237).

The Knowledge Café in its 4th session was held on 23 August 2017 (Session 200). The Café was jointly organized by the Knowledge Management Section in partnership with the Academic and Research Libraries Section, the Library and Research Services for Parliaments Section, and the Continuous Professional Development and Workplace Learning Section. The topic was “New librarians for new times: continuous learning to become change agents in a changing world.” The setting of the room was in 12 round tables. For each table a facilitator coordinated the 20-minutes discussion and a rapporteur was taking notes from the interactive conversation among the participants of the table. The Café was attended by 183 people. For another year, Monica Ertel (**g**) showcased her experienced work in coordinating the Knowledge Café.

The newly established Special Interest Group under the title Digital Humanities / Digital Scholarship is being sponsored by the KM Section. The SIG organized its first session under the topic "The global digital humanities and digital scholarship best practices: what is the role of IFLA and the DH/DS SIG? Lighting talks and interactive conversations." The DH/DS SIG was chaired by its convener, Xuemao Wang (h). Four speakers from four continents talked about libraries which have taken steps to re-define their roles, re-configure their workplace and re-purpose their spaces. The session was attended by 196 delegates and the goal was achieved.

On behalf of the KM Section, the award recipient was Wilda Newman, the Information Coordinator of the Section until 2017. It was jointly awarded with the Academic and Research Libraries Section. The KM Section was selected for its comprehensive communication plan, its Newsletter, the use of several communication channels to promote its activities and the translation of the Section's leaflet in several languages. The Communication Plan is a best practice example which is to be followed by the KM Section and should be updated regularly. Congratulations to Wilda for the great achievement.

Thanks to the Standing Committee members' contributions, the KM brochure was translated in the seven official IFLA languages. It provides the opportunity for all people interested to learn about the KM Section, its goals and activities.

The KM Section held its two business meetings (BM) during the IFLA WLIC 2017. It reported the Section's activities during the conference and planned its events for the IFLA WLIC 2018 in Kuala Lumpur. The year 2017 was the elections year. During the 1st BM the new officers were elected as mentioned in the beginning of this report. The new members of the KM Section are Agnes Hajdu Barat (**i**) and Sylvia Piggott (**j**). Four corresponding members have been nominated (Leda Bultrini, Jane Dysart, Wilda Newman and Steffen Wawra (**k**)). A satellite preconference is planned to be held on 23 August 2018 at Xiamen University Malaysia Campus, Salak Tinggi, and Selangor, Malaysia. The topic is "Is knowledge management the new library science?" and will be chaired by Long Xiao. The webmaster is Spencer Acadia (I) and members of the program team are Frank Cervone (m), Sylvia Piggott and Elisabeth Freyre. The team works closely and eagerly towards the organization of the SM.

A joint open session will be organized with Academic and Research Libraries Section and Rare Books and Special Collections Sections. The topic is "Digital scholarship and knowledge management: building confidence in the digital world". On behalf the KM Section, the joint open session will be co-chaired by Steffen Wawra. Members of the program team are Agnes Hajdu Barát and Liz Turner.

For the fifth time, Monica Ertel will chair the Knowledge Café. The topic is "Continuous learning for successful info pros in the knowledge". It will co-organized with Continuing Professional Development and Workplace Learning and Library and Research Services for Parliaments Sections.

The KM Section will continue to sponsor the DH/DS SIG and its convener, Xuemao Wang. The topic for the SIG session is "The transforming digital scholarship model: from service provider to interdisciplinary partner".

The IFLA Knowledge Management Section organized its Satellite Meeting under the title *New directions in knowledge management* at the [Library of the Wrocław University of Economics](#) in Wrocław, Poland, on Friday 18 August 2017.

Out of the 69 registrations, 40 attendees from 12 countries (Botswana, Canada, China, Egypt, France, Germany, Greece, Italy, Pakistan, Poland, Swaziland and USA) participated in the Satellite Meeting. One keynote speaker and 8 speakers shared their ideas with the audience who participated very lively in the discussion. Additionally, a panel discussion took place and one more speech before the closing remarks led the audience to the activities of the Knowledge Management Section during the WLIC 2017. Only one paper was not presented due to delayed flight arrival for the presenters. But it was managed to present this paper during the KM Open Session.

4. Knowledge Café Summaries

Summary of 2017 World Library and Information Conference Knowledge Café Program

August 12, 2017: Wroclaw, Poland

Sponsored by Continuous Professional Development and Workplace Learning, Knowledge Management and Library and Research Services for Parliaments

The Knowledge Café at the 2017 IFLA World Conference was an interactive discussion focused on the changing and challenging role of librarians in the ever-evolving information world. During the one-hour session, participants had the opportunity to attend two of twelve different table topics. This report summarizes eleven of the tables.

Discussion leaders kicked off the conversations that rapidly turned into insightful and very practical ideas that participants could take home. 5. Open Session summary

The Knowledge Management Open Session #230, “How Does Knowledge Management Inform Change Agency?” was widely attended by over 180 people in the Main Court at the Congress Centre on Thursday, August 24th 2017.

This session’s theme placed emphasis on the role of knowledge managers and information professionals in organizational change management. Our call for proposals invited exploration of methods for communication and training, establishing solidarity with those affected by change, as well as case studies on adoption of innovation in the library, workplace, academe, and society.

The selected presentations showcased examples of Knowledge Management at work preparing, facilitating, and augmenting change. The audience was very attentive and curious with the breadth of topics and venues represented, from universities to public institutions and even the European Parliament. A short Q&A followed the presentations with audience members in the room posing queries to each of the speakers.

The session program team also engaged the audience with a social media Q&A to create a lasting conversation with the speakers and connections with information professionals not able to attend WLIC 2017. The very successful social media invitation saw a spike of almost 100 new interactions with the @IFLA_KM Twitter presence within the hour following the Open Session.



SPOTLIGHT:

What does KM Mean to You?

Jane Dysart, Curator of Curiosity & Partner, Dysart & Jones Associates and Conference Chair, KMWorld (Nov 4-7, 2018)

I'm a librarian by training and I've been in the "KM" business since 2000. Since that time I've been building a worldwide network of KM professionals, colleagues in all types of industries, communities and organizations. I have many conversations using many different channels to find out what people are doing in the work of KM so that I can profile them and have them at speakers for the KMWorld conference which I have programmed and chaired annually in the US since 2000.

I look at KM in the broadest possible way, basically to mean **knowledge sharing**, an activity that librarians, archivists, curators of museums and galleries, and lots of others have been doing for many many years. Towards the end of the last century 'knowledge management' was being used to refer to a number of processes and activities within organizations. The words "knowledge management" have gone in and out of fashion over the last 20+ years but I still believe that knowledge sharing needs to be a core activity of all organizations and communities. Think of volunteer organizations like associations where people are being elected and appointed regularly; how do they pass along the knowledge they gain while doing the activities and responsibilities assigned to them? Or in your own library where people are retiring and new librarians are being hired out of university. How do they learn and get up to speed so they can excel in their job and the library as a whole can thrive?

Building learning organizations with core values of knowledge sharing means creating collaborative, not hierarchical, organizations. It revolves around a number of activities and processes and I'd like to turn to one of my colleagues to explain further. **Stan Garfield**, a long time KM practitioner (bio <https://sites.google.com/site/stangarfield/stangarfield%27sbio>), and frequent speaker for me, has an extensive piece on the definition of KM (<https://www.linkedin.com/pulse/knowledge-management-defined-stan-garfield/>) but what I asked him to do a number of years ago was give me a list of those activities, processes, etc that could make up KM in an organization even if they weren't called KM.
