## A vision for libraries

Libraries enable literate, informed and participative societies. When we look at the future, according to our debates online this means that libraries:

*Survive; be better considered in the overall community; be enabled to preserve and disseminate the historical value of their heritage*

1. Being rule bound policing user behaviour
  2. Working in isolation

### **The main challenges to society (Q8):**

### **The main challenges to libraries (Q9):**

1. Lack of support from funding bodies
  2. Avoiding marginalisation
  3. The false idea that digital is free
  4. Advocating the value of heritage and culture
  5. Being truly global

### **The main professional challenges (Q10):**

1. Decreased funding
  2. Need to incorporate new learnings into professional toolkit
  3. Incorporation of new technology into processes and services
  4. Use of librarianship to address global unbalance
  5. Lack of staff

  3. Preservation of information
  4. Cooperation at national, regional and global level
